Tournament Rules

Eligibility:

- 1) Open to all current 2025/2026 League certified bowlers in San Diego USBC bowling association jurisdiction with minimum of 21 games as of January 1, 2026 with League Sheet Verification. (no Membership Cards sold on site)
- 2) Multi-Members shall have purchased a Multi-Member Card (USBC rule 101) and be currently bowling in a 2025/2026 certified league under SDUSBC jurisdiction with minimum of 21 games as of January 1, 2026, with League Sheet Verification. (no Membership Cards sold on site)

Entering Average:

- 1) Shall be highest certified 2024/2025 winter book average of at least 21 games or more. If none,
- 2) Current average of 21 games or more as of January 1, 2026, with League Sheet Verification. If none,
- 3) Average of 230 shall be assigned.
- 4) If you bowl in Certified Standard Leagues, the highest average shall be used. If you only have a Certified Sport/Challenge condition league average of 21 games or more, this average shall be adjusted according to USBC Conversion Chart. If the bowler does not accept adjusted average, the entry fee shall be refunded.
- 5) USBC rule 319D shall be waived for this Tournament.

General Information & Rules:

- 1) Any NSF returned checks will cost \$35.00 plus any additional bank charges.
- 2) Bowlers shall not be entitled to a refund after fees have been received and lane assignments are issued by association. Exceptions shall be determined by Tournament Manager.
- 3) The Tournament Manager may refuse any team or individual to bowl if determined the entry does not meet membership or tournament requirements.
- 4) In the event a bowler is tardy, may still participate starting in the frame currently being bowled, however shall receive "zero" score for each frame missed.
- 5) If a bowler cannot continue tournament play due to an injury/illness & no replacement is available, the team receives "zero" for that bowler.
- 6) Line-up changes shall not be permitted once entry has been submitted, squad times, and lanes have been assigned by Tournament Mgr.
- 7) Entrants may participate multiple times in team event. In order to place more than once in the prize list for positions standings, at least two (2) players in the lineup must be different. (see USBC rule 315B-1). OPEN DIVISION BOWLERS MAY PARTICIPATE ONLY ONCE IN DOUBLES & SINGLES. WOMEN MAY PARTICIPATE ONCE IN DOUBLES & SINGLES FOR OPEN DIVISION & WOMEN'S DIVISION.
- 8) When a bowler is a member of more than 1 team, the FIRST SERIES bowled shall be used for All Events.
- 9) Two (2) Pro-bowlers per team and one (1) per doubles team is permitted.
- 10) Handicap is based on 90% of 230.
- 11) No practice is permitted on your scheduled lanes the day of tournament.
- 12) **Substitutions:** Are permitted in each event (team/doubles/singles) and shall bowl in same position as person as being replaced. Any monetary arrangements shall be agreed upon between original bowler and substitute with written copy to Tournament Manager. If possible, changes can be made at SDUSBC office prior to entry closing date or at check-in which is 1 hour before squad start time.
- 13) **NO PACERS ALLOWED**
- 14) **Scheduling:** Tournament Manager shall schedule squad times requested on entry if possible. If necessary, due to lack of entries or too few requests for specific squad time, may be changed to different squad/day and team captain shall be notified.
- 15) **All Events:** This is optional & must be paid before entry closing date. Exceptions shall be addressed by Tournament Manager.
- 16) **Awards:** Team Champions (4), Doubles Champions (2), Singles Champion (1), & All Events Champion (1) for Open & Woman (16).
- 17) **Prize Money:** Shall be 100% returned and distribution shall be based on final number of division entries
- 18) Bowlers shall remain on same pair of lanes for both Doubles & Singles events.
- 19) **Equipment:** Altering the surface of bowling balls, using abrasives, cleaner, or polish is prohibited once competition has started. The outer surface may only be cleaned with dry towel. Also, no modifications allowed that may affect bowling ball balance, such as weight, or existing finger/thumb holes also prohibits equipment modification between Doubles and Singles events. No balance holes allowed, must use all holes for gripping. (See Rules, Chapter 8)
Penalty: First offence, bowler is warned, and ball removed from that particular event. Second offence is disqualification from that particular event.
- 20) **Approach Foreign Substance:** No foreign substance is permitted to be applied to bowling shoes or approaches. This includes, but not limited to; powder, rosin, easy slide, soap/slide stone, polish wax, and like products. Any questions/concerns contact Tournament Manager.
Penalty: First offence, bowler is warned. Second offence is disqualification from that particular event.

Protests: USBC Rule 329: Any protests affecting eligibility or general rules MUST be submitted in writing to the Association Manager before awards and prize payments are made. The board of directors shall have the power to act on all protests. The Tournament Committee shall have authority to act on all matters pertaining to the tournament. Appeals from the Tournament Committee shall be filed in writing to National USBC in Arlington, Texas, also prior to awards & prize moneys are distributed. The decision of National USBC is final & binding.

Dress Code:

Collared, sports type t-shirt, long pants, clean jeans (no holes), walking shorts, skorts, and skirts are permitted. UNACCEPTABLE ATTIRE: hats, tank/halter/spaghetti string tops, bib overalls, short-shorts, leggings, baggy sweatpants. Any dress code questions/concerns shall be addressed by the Chairperson of the committee. Tournament Manager's decision is final.
