GENERAL PLAYING RULES

1. Open to all **senior men** (50 and over) as of the tournament date with a valid **SAN DIEGO USBC** Association sanction card and bowling in a league with 21 games or more. Any bowler who is currently and/ or actively participating in a national professional tournament will be ineligible to participate in this tournament. **Multi Members** must have paid local association fees(\$9.00), and be currently bowling in a league in San Diego with 21 games or more.
2. Check in will be **ONE HOUR** prior to scheduled time of bowling.
3. **Qualifying Round:** will consist of eight (8) games bowled moving one pair of lanes after each game. Cut to be based on number of entries. If total number of entries allow cut to be more than 5 bowlers, a one (1) game roll-off shall be bowled with highest score becoming the 5th seed for step ladder finals.
4. Tardy bowlers will receive a zero for any frames missed.
5. **THERE WILL BE NO CARRY OVER OF PINS TO THE FINAL ROUND.**
6. **FINALS: Top 5 Qualifiers bowl step ladder Format.** After each game move one(1) pair of lanes. Ties: a 10th frame roll-off will be bowled to determine the winner of that match. If a tie still exists, a 10th frame roll-off will be bowled until tie is broken.
7. USBC rule 319d will be waived.
8. **Dress Code:** See Front of entry**
9. **NO PAY OFF AT TOURNAMENT SITE.** Payoff will be within 30 days of tournament.
10. Tournament Committee shall decide any and all disputes. Their decision is final unless an appeal is made in accordance with USBC Rule 329.
11. All bowling equipment subject to inspection by tournament official.
